AS SYRIA'S CONFLICT GROUND ON IN 2016-17, PHYSICIANS FOR HUMAN RIGHTS REPEATEDLY CALLED UPON OUR EXTENSIVE EXPERTISE AND NETWORKS ON THE GROUND TO DOCUMENT AND SPEAK OUT ABOUT THE DEVASTATING CONSEQUENCES OF THE FIGHTING. WITHIN HOURS, WE WERE ABLE TO STATE THAT THE ATTACK HAD ALL THE HALLMARKS OF AN ASSAULT WITH A PROHIBITED NERVE AGENT.
